What is PowerSchool Special Programs (PSSP)?

PowerSchool Special Programs (PSSP) is the confidential program used by UCFSD to provide families with digital access to all Special Education, Gifted Education, and Section 504 documents for students served by the school district. The system provides instant, online access to students' files in real time.

Parents access the information through the PowerSchool Parent Portal located at https://ucfsd.powerschool.com/. This portal is provided free of charge to all district families and includes information such as grades and students' schedules, along with providing access to special education, gifted education, and Section 504 documents used by the district. Parents are provided with student specific codes necessary to access students' documents. However, parents are required to create personal usernames and passwords. Each parent should only create one account, but multiple students can be added to each parental account. Parents can configure the system to receive email alerts indicating documents have been added to the system at an email address of their choosing by setting up message forwarding.

Access to PSSP is only available through a web browser, NOT an app on a smartphone or tablet.

Parents are able to view, download, and print documents. Documents requiring a signature may be signed electronically or may be printed and returned via scanned copy or paper copy to the district.

By signing the attached form you agree that you will only receive digital access to all Special Education, Gifted Education, and Section 504 documents. NO PAPER COPIES will be provided. However, if you would like to receive paper copies, please do not complete or sign the form. You will retain access to the digital information through PSSP and the district will send paper copies to the home address on file in PowerSchool. You may revoke this permission at any time by indicating that request in writing to the district.
